TO TERMINATE LEASE, CALL OUR OFFICE. THIS IS VERY IMPORTANT. We will instruct you in how to return the instrument and obtain a receipt for it. **All delinquent fees must be paid before termination of agreement.**

LEASE TERM: Lease expires twelve (12) months from delivery date. To extend lease continue to make monthly payments.

REFUNDS: There will be no refunds of any lease payments made. The instrument may be returned at any time; however any monies covering any unused portion of the lease period is forfeited.

RETURNED CHECK FEE: A fee of \$25.00 will be charged for all returned checks, or declined credit cards for any reason.

INSTRUMENT RETURN POLICY: Instruments must be returned by Payment Due Date, or the lease fee is due and payable, and will be charged to your credit card. No interest in the title of the leased instrument is acquired by the lessee.

MAINTENANCE: No fee will be charged for repairs due to normal usage or minor accidental damage.

Repairs arising from negligence or willful damage will be charged to the lessee. Should instrument be damaged beyond satisfactory repair, it will be replaced with one of equal quality, at a charge of \$100.00 for Group A instruments, \$200.00 for Group B Instruments, and \$350 for Group C Instruments (not listed)

THIS IS NOT A SALES CONTRACT. I agree to lease from DeVoe's Music, the instrument listed above, for the initial period indicated above. Should I wish to continue this lease, quarterly payments, **DUE IN ADVANCE** will be made as indicated above, starting when the initial period concludes. I agree to be responsible for the loss or disappearance of or excessive damage to the instrument, and all lease fees while it is in my possession and until it is returned to DeVoe's Music, and I have obtained a receipt for it. DeVoe's Music may terminate this agreement at its option should the lessee default lease payment by 1 month and may take possession of the instrument wherever found, at school or elsewhere, with or without the knowledge of the lessee, in a peaceful manner. I also have the privilege to return the instrument and cancel this lease at any time providing all lease payments are current. Title to the instrument, or any instrument delivered in replacement thereof, shall be and remain in the name of DeVoe's Music. Customer agrees to pay a late charge of \$5.00 per month on any payment not received by DeVoe's Music within 10 days of the due date and any additional collection costs incurred and reasonable attorney fees. I understand that and authorize all late payments, applicable late fees, and open account invoices will be billed to my credit card.
